#### Seafarer Abandonment Crisis

In 2024, Indian seafarers were the most abandoned worldwide, with 899 cases reported. This marks an 87% increase from 2023, highlighting persistent issues such as unpaid wages, lack of provisions, and abusive working conditions. The prevalence of "Flags of Convenience" exacerbates these challenges by allowing ship owners to evade labour and safety regulations. Times of India

- Educational Initiatives: Providing educational resources and training to enhance the skills and knowledge of seafarers, promoting continuous professional development within the maritime sector.

This MoU aligns with the DGS's broader initiative to elevate seafarers' welfare and safety standards, positively impacting the Indian maritime industry by leveraging Sailors' Society's global expertise.

#### Additional Initiatives Enhancing Seafarers' Welfare:

- Shore Leave Process Improvements: The DGS is actively collaborating with the Ministry of Home Affairs and immigration officials to streamline and expedite the shore leave process for seafarers, aiming to make shore leave more accessible and efficient while ensuring regulatory compliance.
- Establishment of Seafarers' Welfare Board Audit Team (SWBAT): The Seafarers Welfare Fund Society (SWFS) aims to provide and maintain welfare facilities for seafarers both in Indian ports and ports abroad, in accordance with the Merchant Shipping Act, 1958.

These concerted efforts underscore a collective commitment to improving the lives of seafarers, addressing challenges such as mental health issues, unsafe working conditions, and exploitation.
